NTT 1.1 Section C of the Bill of Quantities: Operators Houses.

Item C22.2 specifically refers to SANS 1200 LD. Brick manholes. Contractors are required to price the brick manholes as per the details as set out in SANS 1200 LD page 13, for a manhole with a depth between 1.0 to 1.2m

NTT1.2 Additional Drawings

- 1368-0-1226: Maintenance house Elevations
- 1368-0-1227: Maintenance house Raft Foundation
- 1368-0-1229: Electrical supply
- 1368-0-1230: Septic Tank

The abovementioned drawings must be read in conjunction with items C22.3, C22.5 and C24.2 of the BOQ.

Item C27.1 for main electrical supply to Maintenance houses must make provision for the installation of the electrical supply from the Eskom connection to the houses that must include the electrical cable for a 60 AMP supply to the house and for a total length of 140m of trench excavations and backfill for each house. The cable must be a 16mm square copper 3 core cable.

NTT1.3 Section D: Refurbishment.

All item and materials as listed in this Section shall make provision for the supply and installation of all materials as listed in the BOQ.

Attached is Drawing 1368-0-106: Details of standpipe and connection, Item D29 must be read in conjunction of the listed drawing, the price for the isolating valve shall include supply and installation.
