### **SECTION 2: PROCEDURE FOR SUBMISSION OF QUOTATIONS**

1. No quotation will be considered unless submitted on this RFQ document.
2. Telephonic, telegraphic, facsimile or emailed submissions, or any other electronic submissions, will not be accepted, unless indicated otherwise in this document.
3. Submissions must be marked with the RFQ description and reference number, sealed and deposited in the tender box on or before the closing date and time for submissions.
4. Submissions deposited in the tender box after the closing time or closing date will be considered to be late.
5. Late submissions will not be accepted, and where practicable, shall be returned unopened to the bidder.
6. O.R. Tambo District Municipality accepts no responsibility for ensuring that RFQ submissions are placed in the correct box, and submissions placed in the incorrect box will not be accepted.
7. Bidders are entitled to submit one quotation only, either as a single tendering entity or as a member of a joint venture or consortium.
8. Bidders are responsible for all costs incurred in the preparation and submission of their quotation.
9. The RFQ submission must be signed by a person or persons duly authorised to do so.
10. Once the quotation is awarded, all purchases will be made through an official O.R. Tambo District Municipality purchase order.
11. No goods or services must be delivered or provided before an official order has been sent to and accepted by the successful bidder.

## SECTION 3: TEST FOR RESPONSIVENESS

### Invalid submissions

Quotations shall be invalid if:

1. The submission is not completed in non-erasable ink.
2. The bidder, if he or she is a natural person, is in the service of the state, or if not a natural person, a director, manager, principal shareholder or stakeholder of the bidder is in the service of the state.
3. The bidder is listed on the National Treasury Register of Tender Defaulters and / or List of Restricted Suppliers and is restricted from doing business with the public sector.
4. The bidder has been restricted from doing business with O.R. Tambo District Municipality in terms of its supply chain management policy and procedures.

### Non-responsive submissions

Quotations will be declared as non-responsive and eliminated from further evaluation in the following instances:

1. The submission does not comply with the mandatory requirements of the RFQ, if any, including any minimum evaluation criteria.
2. The bidder's tax matters are found not to be in order upon verification by the Municipality on CSD, and the bidder fails to ensure that its tax matters are in order within such timeframe as may be granted by the municipality.
3. Where the bidder is not registered on CSD.
4. Where the bidder is not registered on the municipal supplier database, or does not meet the listing criteria for accredited suppliers specified in the municipality's SCM Policy, and does not register on the database or meet the listing criteria within such timeframe as may be granted by the municipality.

## SECTION 4: EVALUATION OF QUOTATIONS

### Evaluation of quotations

1. Quotation submissions will be evaluated on the criteria specified in this document.
2. Submissions will be evaluated in accordance with the 80/20 price and preferential procurement points system.
3. Unless stated otherwise in this document, the quotation will be awarded to the bidder who meets the all the requirements of the RFQ and who scores the highest total price and BBEE points.

## SECTION 5: SPECIFICATIONS AND EVALUATION CRITERIA

### SPECIFICATION

#### Purpose

This serves to request two (2) water tankers for water carting as an intervention for areas with water interruptions and no water infrastructure. The project requires water carting services from the services provider to support the rendering of the necessary water supply functions by the district municipality. It entails carting of water to area within the Jurisdiction of Ingquza Hill Local Municipality. The services that are required will be for the 1-month period and will be based on the call down system/ method (services to be rendered as and when required). A mechanism in this regard will be developed on the communication and consultation with the provider when the necessary services are required. Water deliveries will be on an as and when required basis and upon official instruction signed by the Director of Water and Sanitation Services.

#### Deliverables

Two (2) water trucks with a minimum of 10 000litres of capacity will be required for each local municipality jurisdiction. Carting of quality water and deliver it to the identified communities of the district. It must be noted that in rendering these services the service provider must have mechanism to provide portfolio of evidence in delivering the task. Water deliveries will be on an as and when required basis and upon official instruction signed by the Director of Water and Sanitation Services.

## Truck Specifications

- Truck must comply with all necessary SABS standards including transportation of drinking water standards and Safety Acts.
- Trucks must be in a good condition and roadworthy at all times to ensure effective service delivery.
- Tankers should have a capacity of 10 000 Litres
- Water tankers should be disinfected before commencement with the contract and it must not be used for any other purpose other than intended use for water quality control.

## Design and fit-out

- Tanks used for the storage and transportation of potable water are required to be constructed of materials which will not compromise the safety of the water.
- Water carrier tanks fabricated from mild steel are to be coated internally with an approved material suitable and safe for contact with drinking water.
- The internal coating of mild steel water carrier tanks must not be carried out until all welding has been completed and the interior surfaces of the tanks have been thoroughly descaled and cleaned.
- The interior of the water carrier tank must be maintained in a clean, hygienic condition and be free from rust and foreign matter.
- The tank must be able to be fully drained and have a sufficient opening for inspection and cleaning of the contact surfaces.
- The exterior surface of the domestic water carrying vehicle, pipelines, fittings and other equipment must be kept in a clean condition at all times and not cause contamination of the water.
- Containers and fittings used for the transportation and delivery of potable water shall not be used for any other purpose.
- The water carrier tank must not be used to convey any other liquid other than potable water suitable for human consumption.

## Signage

To ensure the tanker is not used for purposes other than the transport of potable water, the signage should be prominently displayed,



## Tanker disinfection

Regular maintenance is essential in ensuring the drinking water provided by water carriers is safe. Water carriers should clean and sanitise their tanks, hoses and any other equipment that comes into contact with drinking water at least every six months.

## Record Keeping

The tanker driver should ensure that all activities undertaken by a tanker are neatly recorded with data of names of recipients; address of recipients; signature of recipients and signature of local authority (ward Cllr; ward committee; tribal office; CDW). A draft template of logbook will be made available to successful bidders.

## Water Sources

Water must be collected only in approved municipal sources. Only drinking water sources must be used for collection of water.

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

**2. DEFINITIONS**

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);



- (e) “**EME**” means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) “**functionality**” means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) “**prices**” includes all applicable taxes less all unconditional discounts;
- (h) “**proof of B-BBEE status level of contributor**” means:
  - 1) B-BBEE Status level certificate issued by an authorized body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) “**QSE**” means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

### 3. POINTS AWARDED FOR PRICE

#### 3.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:
